Student's Right to Cancel / Refund Information

A student may withdraw from the seminary at any time by completing the necessary paperwork through the Registrar's office. A student cannot assume that a class is dropped simply by not attending.

Students who withdraw before the start of a term will be refunded any tuition paid. However, registration fees and application fees are non-refundable.

Students who withdraw after the start of a term but before 50% of a course is completed will receive refunds based on the following:

When a student drops a class after the first day of the term, the student must pay for contact hours attended (or even those not attended if the student fails to notify the Registrar's office).

The student will receive a refund or adjustment to his/her account. At the current rates, tuition is \$24 per contact hour. Fees are nonrefundable.

For Internet courses, the professor will verify the last date of attendance to calculate contact hours in the course in order to arrive at the amount of refund or adjustment.

At Central Baptist Theological Seminary, 1 credit is the equivalent of 15 contact hours.

Students who withdraw after the start of a term but after 50% of a course is completed will not receive any refund.

Loan Information

If the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds.

If the student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund.

If the student is eligible for a loan guaranteed by the federal or state government and the student defaults on the loan, both of the following may occur:

- (1) The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.
- (2) The student may not be eligible for any other federal student financial aid at another institution or other government assistance until the loan is repaid.

Program Costs

The following costs are associated with the Master of Divinity program offered at Central Baptist Theological Seminary's California Center and reflect full-time continuous enrollment. The costs do not account for any scholarships or grants provided to the student by the seminary or sources outside the seminary.

Student Tuition Recovery Fund
